

EGSC MEMBERSHIP TERMS & CONDITIONS

Membership of East Grinstead Sports Club Limited, hereinafter known 'the club' is conditional upon you observing the terms and conditions as set out below. We reserve the right to amend or add to these conditions.

MEMBERSHIP

- 1. Membership fees are inclusive of 20% VAT.
- 2. Membership of The Club is a pre requisite of joining any affiliated or founder sports clubs and any other associated clubs or businesses that are subject to this agreement.
- 3. Membership entitles you to various benefits and discounts that are available to members. These are available at the time of joining and from the club reception. They may vary from time to time and can be withdrawn or added to with as much notice as possible given at the club.
- 4. You will be issued with a membership card, which you must bring with you when you use the club and its facilities, with all benefits subject to production of a valid membership card. Replacement cards will be charged at the current rate, available from reception.
- 5. Memberships are non-transferable or refundable
- Our membership year is 1st October to 30th September and we will review our fees annually and will notify you no less than 30 days before they take effect. Your membership will not be affected until your next renewal date.

PROPERTY

HEALTH & SAFETY

- 8. We regard Health and Safety or our members, staff and visitors paramount. If you observe anything that may affect any person's well-being please notify a member of the team immediately
- 9. Whilst we accept our responsibility in creating a safe environment, as a member you also have a duty to ensure you do not compromise the welfare and safety of others
- 10. We operate a child protection policy at the club which is available on request
- 11. If you or your guests or associates have an accident that results in personal injury you must report it to a member of the staff before leaving the premises so that the circumstances can be fully recorded.
- 12. For your own safety and enjoyment please follow all instructions for the use of the facilities whether oral or written.
- 13. We recommend that all users of the club that wish to make use of the sporting facilities and / or are subsequently joining an affiliated sports club or a like seek advice from their GP prior to joining as a matter of caution.
- 14. By signing your application form you agree to use the club and its facilities entirely at your own risk.

FACILITIES & EQUIPMENT

- 15. We will endeavour to keep all equipment and facilities available
- 16. Maintenance and essential repair work may mean that some facilities are out of use at certain times

TERMINATION

- 17. We will terminate your membership if you fail to abide by these terms and conditions or behaviour by you, your guests or associates is deemed unacceptable by the management of the club
- 18. We reserve the right to terminate any membership for any reasonable reason.
- 19. Our disciplinary and appeals process is available on request
- 20. You may not transfer your membership to another person and memberships are non-refundable e.g.' for moving house etc.

VARIATION OF THESE TERMS AND CONDITIONS

- 21. We reserve the right and will, if necessary, change these terms and conditions. If we do so we will notify you at the club on the club member's notice board.
- 22. In the event there is any misunderstanding as to the interpretation of these terms and conditions the decision of the General Manager and the Board of Directors is final.
